However, I recognize that The Grateful Dog Training and Daycare, Inc. is not responsible for any unintentional errors, omissions, or incorrect assertions. I understand that the recommendation of any product or service is not a guarantee of my satisfaction with that product or service. Further, I am and will remain responsible for the actions of my dog at all times and I hereby agree to indemnify and hold harmless The Grateful Dog Training and Daycare, Inc. of any and all claims of injury, expense, costs, or damages caused by the actions of my dog while under The Grateful Dog Training and Daycare, Inc. instruction or control and under my own care as a result of following training instructions. I have been told by The Grateful Dog Training and Daycare, Inc. and understand the inherent risks of owning a dog, including but not limited to the risk of dog bites to myself or others.
- 2. I authorize Emergency medical care to be provided for my dog by Green Mountain Veterinary Hospital, Rutland Veterinary Hospital and Surgical Center, or an appropriate alternate to be determined by The Grateful Dog Training and Daycare, Inc. in the event that the regular veterinarian is not available or that closer care is required. I understand I am responsible for any and all veterinary costs and agree to reimburse The Grateful Dog Training and Daycare, Inc. for any charges related to emergency care.
- 3. I authorize The Grateful Dog Training and Daycare, Inc. to administer and seek First Aid and resuscitative care for my dog as determined appropriate by The Grateful Dog Training and Daycare, Inc. and I agree to indemnify and hold harmless The Grateful Dog Training and Daycare, Inc. for any and all results thereof.
- 4. I understand that all dogs will be boarded at owner's home address of 1146 Danby Pawlet Road, Pawlet, Vermont. Owner gives the Grateful Dog Training and Daycare, it's owners, operators, and/or staff permission to transport dog/dogs to and from the Pawlet location for boarding purposes. They further understand the inherent risks associated with transportation such as, but not limited to, loss or injury due to accident; owner agrees to assume all risks and financial costs associated with said transportation.
- 5. I understand that my dogs will be trained using positive reinforcement methods. I also understand that although my dogs will learn multiple behaviors, basic obedience, new routines, and management while in the care of the Grateful Dog, it is my responsibility to maintain this learning upon their return to the home environment. Dogs do not generalize well. This means that behavior taught while in our care will only be solidified through clear, calm and consistent repetition once home. The Grateful Dog recommends owners commitment to continued education through group classes and private instruction to proof and generalize training.
- 6. Animal behavior is never fixed or static; it changes depending on circumstance and environment. Even trained behaviors will fade or extinguish over time without consistent repetition and practice. Especially in cases of fear or aggression, although behavior may be modified, the dog is never "cured". A dog's behavior is ultimately the responsibility of the owner
